# 1. Welcome

# **Matthew Day**

Mr Day addressed the Committee regarding his 7 January 2023 noise complaint, which concerned low flying fixed wing general aviation aircraft over Jacks Point and the intensity experienced at certain times of the day.

Jon Brooks confirmed that Airways endeavour to track light fixed wing aircraft returning from Milford between the residential areas north of Hanley Farm and Peninsula hill. However due to air traffic and separation distances required, Airways can sometimes be required to send general aviation further south before turning back towards the aerodrome, which will have an impact over Jacks Point.

Mr Day was comfortable with the explanation given by Airways, and expressed his thanks to the Committee.

# 6.2 Noise Mitigation Programme – General Update

Noise mitigation work is underway within the inner-noise boundary on two houses, with a third to start in mid-March. One additional house is in the design phase and another in the scoping phase.

Within the mid-noise boundary, Presbyterian Support Services have expressed strong interest in the programme for their units on McBride St now that work will be 100% funded by QAC.

Additionally, a promotion of the 100% funding offer for noise mitigation work within the mid-noise boundary will be undertaken in March/April 2023.

# 6.3 Updated procedures

Jon Brooks, Airways gave an overview on the updated procedures for approaches and departures for helicopters and fixed wing aircraft. These new procedures will introduce safety improvements on the airfield for departing and arriving general aviation aircraft and will use existing flight paths. The purpose is to ensure more consistent processes are followed to achieve better safety outcomes.

Being the last meeting for Chair Jane Taylor, the CEO thanked Jane for her chairmanship of the committee over the past decade. Jane was instrumental as founding Chair of the committee in June 2013 and her guidance and leadership has been hugely appreciated. QAC are currently recruiting for a new Chair.

#### 6.1 Noise contours update

The 2022 Compliance Annual Aircraft Noise Contours (CAANC) were reported. All noise activity was within our noise boundaries — compliance was achieved.

The Projected Annual Aircraft Noise Contours (PAANCs) are being prepared and will be presented at the next meeting. The Chair requested that these be circulated prior to the meeting.

# 6.2 Noise Mitigation Programme – General Update

Three Inner Noise Boundary properties have had noise mitigation completed this reporting. These are owned by QAC.

Construction works at 100A McBride will commence once the engagement process is finalised.

There have been no additional refusals during this period.

A letterbox drop has been conducted for all mid properties this reporting period. Additionally, formal letters will be sent via post to all affected property owners. To help facilitate communication, a QAC mailbox account (noise-mitigation@queenstownairport.co.nz) has been established to receive correspondence.

#### 6.3 Draft Master Plan

Consultation has begun on the draft Master Plan. From a noise point of view, the proposed relocation of general aviation from Lucas Place will be beneficial to those local residents close to the current general aviation precinct.

QAC and QLDC are working in partnership on the public consultation which is running until the 23 June.

#### 7. General Business

Deep asphalt repairs at turning nodes on the main runway (at both ends 05 and 23) were carried out on the evening of 14 and 15 May 2023. A letter was circulated to close proximity neighbours along McBride Street communicating the planned runway maintenance. No noise complaints have been received.

James Stokes updated the group on Glenorchy Air's upcoming sunrise flight. This early morning departure has proved popular in the past and will run from 1 June – 15 August.

#### 5.1 Aircraft Activities

The Committee reviewed the aircraft activities over the reporting period, noting that annual movements for 2023 are tracking close to movements in 2019.

# 6. Operational Report

# 6.1 Noise contours update

The Queenstown Airport 2022 Noise Compliance Report was circulated to the Committee on 6 July 2023 via email and subsequently uploaded to the QAC website.

In the process of completing the report, it was established that some of the assumptions inherent in the model should be reviewed to better reflect the operational use of the runways.

To ensure consistency of the contours within the 2022 compliance report, the contours were re-run resulting in a minor refinement of the CAANC from those presented at the 29 May QALC meeting.

All noise activity is within our noise boundaries and compliance has been achieved.

The current noise modelling software used (Integrated Noise Model) is being reviewed by our external noise consultants, Marshall Day Acoustics. An update and recommendation will be provided at the next meeting.

# 6.2 Noise Mitigation Programme – General Update

The Noise Mitigation Treatment Programme has continued to gain traction and generate significant interest within the community. During the reporting period, 21 homes were assessed for Noise Mitigation Treatment.

The assessments involved detailed inspections to determine the suitability and scope of treatment for each property. One homeowner has agreed to proceed with the noise mitigation treatment, and the scheduled commencement date has been set for the upcoming period. Quotes for noise mitigation treatment are currently under review for ten properties, with quotes for another ten properties imminent.

#### 7. General Business

The QAC CEO gave an update on the draft Master Plan, including findings from the community consultation held in partnership with QLDC.

It was noted that Amway will be visiting Queenstown in November 2023, over a 10 week period. This will be a busy period for general aviation and (weather depending) will likely see an increase in movements over the next period.

# 5. Noise Model Recommendation

The committee considered the following information provided to the committee:

The Queenstown Lakes Operative District Plan (ODP) Designation for Queenstown Airport states at D1 condition 7(b) that:

"The term Annual Aircraft Noise Contours (AANC) shall be defined as the annual Ldn contours 55 dB, 60 dB, and 65dB that have been derived using aircraft noise prediction software to be determined by the Queenstown Airport Liaison Committee (QALC) in accordance with the Noise Management Plan (NMP) and records of actual aircraft movements for the busiest three consecutive months of the preceding year."

When the Noise Boundaries became operative in 2013, MDA recommended the use of INM v7a (being the INM version used to prepare the ODP boundaries at that time) as the software version used for compliance assessment. MDA understands the QALC accepted this and therefore this version has been used for every compliance assessment since. Section 3.2 of the Noise Management Plan (NMP) sets out this requirement:

"Each year, QAC, shall produce 55 dB, 60 dB and 65 dB AANCs, using airport noise prediction software INM v7a and records of actual aircraft movements for the busiest three consecutive months of the preceding year. QALC shall have the discretion to require future predictions to be modelled using new or improved software which supersedes INMv7a."

In the 2022 compliance report, Marshall Day Acoustics (MDA) recommended that QAC look to change reporting models from INM to the AEDT model. QAC requested that Marshall Day Acoustics undertake a comparative analysis of the INM and AEDT for the QALC's reference which is attached to these minutes as Appendix 1.

The committee noted this information and the report provided by Marshall Day Acoustics. The Chair thanked Steve Peakall for his report, and for attending the meeting to answer any questions.

Confirmation was sought as to the status of the operative district plan vs the proposed district plan regarding the references set our below, whilst noting that the content / wording of the designation was unaffected. QAC management to confirm this.

#### The QALC:

- i) Approved the change of the model used for compliance modelling from the INM v7a, to the AEDT model; and
- ii) Approved updating section 3.2 of the Noise Management Plan to reflect this change, which will be brought back to the next QALC meeting.

# 7.1 Noise contours update

The 2022 Compliance Annual Aircraft Noise Contours (CAANC) were presented at the May 2023 meeting.

The Projected Annual Aircraft Noise Contours (PAANCs) for 2023 were circulated to the QALC via email on 6 July 2023, and presented to the QALC at the August 2023 meeting.

Both of these documents form part of the Queenstown Airport 2022 Noise Compliance Report which has been uploaded to the QAC website.

# 7.2 Noise Mitigation Programme – General Update

The Noise Mitigation Treatment Programme has continued to gain traction and generate significant interest within the community.

During the period since the previous meeting, an additional 6 homes were assessed for Noise Mitigation Treatment. The assessments involved detailed inspections to determine the suitability and scope of treatment for each property. Seven homeowners have agreed to proceed with the noise mitigation treatment, with treatment completed on two properties within the period (99 and 100a McBride), and construction scheduled to commence on 5 properties (42a & 46a Douglas, 8 Lake, 95a & 95 McBride Sts) this upcoming period. There were 2 refusals during the period.

As of this report, quotes for 3 properties have been recently received and are ready to be presented to Homeowners, with 6 quotes outstanding with Naylor Love.

#### 8. General Business

An update on the Queenstown Airport Master Plan was provided, with QAC management noting that the draft master plan had been amended following feedback from the community and stakeholders. The final draft master plan was considered and endorsed by QLDC in its full council meeting of 16 November 2023, and was due to be considered for approval by the QAC Board at it meeting of 7 December 2023.
