QAC was asked to confirm the status of the Operative District Plan referred to in the Noise Management Plan, to ensure the references are correct.

It is confirmed that the Operative District Plan contains objectives, policies and (in some cases) rules for resource management activities that continue to apply until there are no more appeals on the Proposed District Plan provisions, and the Council

makes the Proposed District Plan operative. This includes airport related provisions in zones. The Operative District Plan also sets out the requirements of the Noise Management Plan in Designation 2, section D.1 of Appendix A1, however this designation was carried over into the Proposed District Plan as described below.

The District Plan review began in 2015, and is referred to as the Proposed District Plan. The Proposed District Plan also sets out the requirements of the Noise Management Plan in Designation 2, section D and D1. There are no appeals remaining outstanding for Designations.

The requiring authority (QAC) has made its decision on the recommendations of the QLDC regarding this designation, and it is now treated as a rule under section 175(2)(a) of the Resource Management Act. It must therefore be 'treated as operative' under section 86F.

As such, the Noise Management Plan will be updated to refer to the PDP Designation, with changes brought to a future QALC meeting for approval.
